## 3.1 Network Meetings

# **Topical Meetings**

It was decided that the next stage of the network would be to create smaller clusters of members in key technology areas with an aim to provide topical meetings for members of the network. It was decided that meetings in the following four areas would encourage an exchange of research and ideas;

Optical Data Storage Signal Processing for Data Storage Magnetic Data Storage Networked Storage

These areas will hold topical meetings funded by the Network and be the driving force behind potential projects, collaboration and additional funding. All of the cluster meetings and their funding must be agreed by the Steering Committee.

Meetings in the areas of Optical Data Storage, Signal Processing and Magnetic Data Storage are to be held in July 2005. The Networked Storage topical meeting will be held in July or September.

The request of the UK Magnetics Society for a joint meeting on Magnetic Data Storage should also be taken into account when organising this meeting.

ET will discuss with colleagues at Xyratex to progress ideas on this possible meeting (ET to formulate possible plans and invited speakers)

In addition to technical presentations, time should be made at each meeting to discuss funding opportunities and possibilities

Once a few invited speakers for each meeting have been arranged a mailing to all network members informing them of the topical meetings and asking for contributed presentations will be made.

The venues for meetings were not really discussed in detail, but in principle they could be held anywhere (at company locations, at Universities, in hotels).

DM suggested that it may be worth meeting at a hotel the night before the meeting so people could network socially rather than within the constraints of the actual meeting. This decision would be taken after contact had been made with possible members of the cluster groups.

### 3.2 DSNetUK role and links with other organizations

ET suggested that the committee should think about how the network links and collaborates with similar organisations in other parts of the world.

DJ suggested that we provide a newsletter to all members and also that members who attend relevant conferences should write a summary for all other members in that field.

BM said that perhaps the network should wait to see how the topical meetings evolve and they could be a vehicle for links with others in industry/academia.

BM suggested the now defunct Triumph (Tape recording instrumentation users and manufacturers forum) might provide a link to more UK-based members.

An e-mail list for Triumf members should be available, and it was agreed that a circular to Triumf ex-members should be made

CDW said that the network had made an approach to join INSIC in the USA, which was greeted warmly. INSIC would have reciprocal membership rights.

BM asked whether the network should become more involved with Europe. CDW stated that IMST was the primary network-type organisation in Europe, and DSNetUK has good representation in all IMST activities (via CDW).

In fact IMST has been invited by EC IST and FET Programme Managers to a meeting in Brussels on 9th June to discuss possibilities for data storage research and Framework 7 research priorities. CDW has suggested that DSNetUK SC members attend this meeting also - ET and AP agreed to attend if possible.

### 3.3 Network Funding Applications

Members should be informed of this possibility and a request 'button' put on the website that allows for the logging of funding applications and the provision of a support letter.
